1. The Government of Kingdom of Thailand has applied for financing from the **Asian Infrastructure Investment Bank (AIIB or the Bank)** toward the cost of the **U-Tapao International Airport Expansion Project**, and intends to apply part of the proceeds toward payments under the contract for C2.1 - Construction of Second Runway and Taxiway. This will include the construction of a 3,505-meter length by 60-meter width runway developed to accommodate all aircraft models. The runway alignment will be constructed parallel to and be located approximately 1,140 meters from the existing runway. The construction includes the relevant earthworks and site preparation, taxiway, drainage system and structure, visual aid system, airfield ground lighting system and pump station. (Hereinafter called as 'Package C2.1'). The Estimated Procurement Cost of the Construction of the Second Runway and Taxiway is THB 15,200,123,971.91 (Fifteen billion two hundred million one hundred twenty-three thousand nine hundred seventy-one baht and ninety-one satang Thai Baht), funded by AIIB's loan (85% of the procurement cost), and the Government of Kingdom of Thailand shall provided a 15% counterpart fund. The only 0% rate of value-added tax (VAT) applied to AIIB's financing.
2. U-Tapao International Airport Second Runway and Taxiways Project Management Unit (UTPRW-PMU), now invites sealed Tenders from eligible Tenderers for Construction of Second Runway and Taxiways fulfilling the qualification criteria as mentioned in the Tender Document. The completion period of work is **1,095 days**. Tenderers are advised to refer the clauses on eligibility (Section 1, Clause 4) and minimum qualification criteria (Section III - Evaluation and Qualification Criteria) given in Part 1 of Tender Document, to the participation in the Tender.
3. Tendering will be conducted through International Open Competitive Tendering procedures as specified in the Bank's Procurement Instructions for Recipients (PIR), and is open to all eligible Tenderers as defined in the PIR.

4. Interested eligible Tenderers may obtain further information from the Office of U-Tapao International Airport Second Runway and Taxiways Project management UNIT, and inspect the Tender Document during office hours 08:30 a.m. to 04:30 p.m. GMT+7 at the address given below.
5. The Tender Document can be purchased by interested eligible Tenderers upon the submission of a written request to the address below and upon payment of a nonrefundable fee of THB 50,000 (Fifty Thousand Thai Bath only). The method of payment will be through a bank transfer of the following bank account details below. The Tender Document could be downloaded via an email link URL. Access to the documents is granted upon confirmation of payment from UTPRW-PMU.

All envelopes marked "FINANCIAL PART" shall remain unopened and will be held in safe custody of the Employer until the second public Tender opening.
